3 Rounds of Scratch Competition

1st Round

All teams bowl 3 actual games with the right lane skipping 3 or 4 pairs to the right and left lane skipping 3 or 4 pairs to the left after each game. The field is then cut to the top 8 teams.

2nd Round

Scores will be dropped after the 1st round. Each remaining team will bowl 8 games of round robin, head-to-head Baker competition. The 8th game will be a position round. Each match the winning team is awarded 20 bonus pins.

3rd Round

The top 3 teams will advance to the stepladder finals. All scores are dropped again at this point. The 3rd seed bowls the 2nd two seed two games, one on each lane with the total pinfall deciding the championship pairing. That team will then bowl 2 games against the 1st place seed with total pinfall deciding the champion.

Elkhart Team Challenge Tournament Rules

1. Check-in time is 9:00 a.m. Starting time is 10:00 a.m.
2. Competition is scratch
3. Open to all male and female bowlers except PBA or former PWBA bowlers who have won a national title. Teams limited to one Professional Bowlers Association member per team, **REGARDLESS OF CLASSIFICATION**.
4. All bowlers must be USBC certified. If not certified, bowler must pay the current certification fee to participate. This tournament is USBC certified.
5. Adjustments in lineups may be done at the end of any Baker match. The 6th bowler may enter in at any time if bowler is on the roster.
- 5.1 Per USBC Tournament rules, any tardy bowler arriving after the tournament has started, receives a zero for each frame missed.
6. At the end of a game during the 1st round, a bowler may be replaced by the 6th bowler on the roster and must finish the remaining game. The replaced bowler can enter the following game by notifying the Tournament Director.
- 6.1 If the 6th bowler comes in to replace a teammate and that bowler was in the individual pot, he/she forfeits those pots. The 6th bowler does not take the replaced bowler's pot chances. This excludes team brackets.
- 6.2 If there is a tie going to the final position round baker match, the team that was seeded higher at the end of qualifying will be the higher seed for that last baker match. Example: if there is a tie for 3rd and 4th place, whichever team was seeded higher at the end of qualifying will be the team on the left lane.
7. 2nd round starts shortly after qualifying, finals immediately after 2nd round.
8. 1 in 3 teams will cash.
9. All ties for last qualifying position will result in a one game, Baker-style roll-off. Total pins will determine the winner.
